Most vehicles are required to undergo a smog check every two years and for certain models, every year. As of 2015, California began allowing OBDII tailpipe testing instead of for tailpipe sampling. If your vehicle can't be tested via OBDII, a tailpipe emission sample will be taken. Regular maintenance and adherence to factory specifications should result in no issues during a smog test. Engine efficiency is optimized when warm, driving your vehicle for at least 15 minutes prior to testing ensures accurate results. If recent service disconnected the battery, resetting the OBD II sensors may take several days to repopulate with data. If you're unable to have your vehicle tested due to empty OBDII sensor values, our technician will explain the issue. Test-only locations cannot perform repairs; you must address any issues promptly to register your vehicle with the DMV. Any auto repair facility can perform necessary services. California law requires smog checks for changes of ownership or when registering a new vehicle in the state.
