Jimmy Butler signs \$111M deal with Warriors, ends saga with Heat in megadeal trade, ESPN confirmsThe Golden State Warriors have finalized a multiteam megadeal that includes the signing of Jimmy Butler to a six-year, \$111 million contract, according to sources. The agreement includes forwards Andrew Wiggins and Kyle Anderson, as well as guard Dennis Schroder being sent to the Utah Jazz in exchange for forward P.J. Tucker from Miami.The Golden State Warriors would not have made it to '22 without Steph Curry and Draymond Green. Their dedication is something that cannot be taught, it's in their blood. It's going to take some getting used to, but everyone is doing the best they can. Kerr has said he does not want any "desperate" trades. They are in a good position right now. The team had concerns about depth. Golden State played Utah at 10th place in the Western Conference. They made a big trade that ends Butler's time with Miami. The Heat were not happy with him lately. He was known for being strong-willed, which fit their "Heat Culture." Now they have to adjust without him. The Warriors' coach has said this about consistency and clarity. It's something the team needs to get over. They are trying to find a new rhythm with new players like Kuminga and Podziemski. The trade made things easier for Golden State. Their odds went up to win the championship, as well as take the Western Conference title and Pacific Division crown.They've got a tricky situation on their hands: With Naz Reid returning under a new five-year, \$125 million deal, the Timberwolves are facing a tight financial spot, as both Julius Randle and Nickeil Alexander-Walker are set to become free agents. Randle has a player option, which makes it possible that they'll retain all three players, but that would be a tough fit and compromise future salary space. Focusing on Reid and Randle, and counting on rising sophomores Rob Dillingham and Terrence Shannon Jr. to fill in for Alexander-Walker next season could be the way forward.One move they should make is replacing Randle's player option with a three-year pact plus a nonguaranteed fourth year. This would strike a balance between pushing to win now and remaining flexible in the future. Randle has proven himself as a solid regular-season contributor, and he leveled up as a valuable playoff performer this spring.KramerDenver NuggetsHeeding Nikola Jokic's advice could be key for the Nuggets: "We definitely need to figure out a way to get more depth," Jokic said after their second-round loss. The team needs to address their lack of rotation and bench depth, similar to last offseason. They can explore free agents, but that might come at the cost of starter Michael Porter Jr.One move they should make is signing Luke Kornet to a two-year, \$11.7 million contract using the tax midlevel exception. Kornet averaged 6.0 points and 5.3 rebounds in 18 minutes per game last season for Boston. The Nuggets need to find a backup center to Jokic.Cleveland CavaliersKeeping their roster intact is not an option, as it would cost more than a quarter of a billion dollars in luxury taxes alone. Trimming payroll and making moves to alleviate the cap crunch could be the way forward.One move they should make is trading away one or both of Jarrett Allen and Max Strus to get under the dreaded second apron. The Cavs have signaled that they're unlikely to bring back free agent Ty Jerome, so anyone else they hold onto will drive next season's salary number higher.Houston RocketsYou could argue that the Rockets have already made their moves, acquiring Kevin Durant and signing Fred VanVleet and Aaron Holiday to new contracts. However, there are still a few more moves to be made.One move they should make is signing Dorian Finney-Smith to a two-year, \$28 million contract if he opts out of his deal with the Lakers. The team would need to waive Jock Landale's non-guaranteed contract to use the full non-tax midlevel exception. Expanding the roster with Durant and Jabari Smith Jr., who are both eligible to sign extensions until October 20, could be a key move.Indiana PacersThe Pacers can return every key player from their Finals run in 2025-26, but one exception is Tyrese Haliburton's absence due to an Achilles injury. Ensuring Myles Turner's return through a new long-term deal is crucial for the team, as they have no other depth at the position.One move they should make is re-signing Turner for three years and \$80 million. In a vacuum, this would be a smart move, but it's unclear how the Pacers will address their salary cap situation in the coming offseason.The NBA's offseason is a crucial period for teams looking to improve their rosters and make strategic moves to contend for championships. For teams with limited cap space, finding creative solutions to strengthen their benches and address key positions can be a challenge.The NBA offseason is heating up, and teams are making moves to strengthen their rosters without breaking the bank. The Detroit Pistons can use this momentum as a catalyst for change, adding reliability at the backup power forward spot, a position they struggled with during the playoffs when Isaiah Stewart suffered an injury.The 76ers are in a precarious position regarding their restricted free agent, Jonathan Kuminga. To re-sign him, they would have to utilize an exception, making him a viable target for the San Antonio Spurs. The Miami Heat could acquire Kuminga by offering a package of players and draft picks, taking advantage of the Heat's allowance for trading up to two future firsts.###ARTICLEThe NBA offseason is in full swing, with teams looking to make moves that will set them up for success next season. Here's how some teams can ace their offseason:**Phoenix Suns**: The Suns should try to find a way for Bradley Beal to take a contract buyout. If Beal reduces his salary and then gets waived, the Suns would save over \$200 million and be able to operate under both aprons.Meanwhile, they should sign Chris Paul to a one-year, \$3.6 million contract. This would be fitting since Paul was traded for Beal, and he could help mentor Jalen Green while still contributing on the court.**New Orleans Pelicans**: The Pelicans can use their non-taxpayer midlevel exception to add depth, particularly with players who have size to play power forward due to Zion Williamson's injury history. They should make a run at Sacramento forward Jake LaRavia, who is in an unusual situation and could be lured away for double his current salary.**Toronto Raptors**: After parting ways with longtime president Masai Ujiri, the Raptors should reduce their salary commitments while developing a better roster blend. Dealing RJ Barrett, who will earn nearly \$28 million this year, would make the team less top-heavy and ease the roster logjam.One move they should make is trading Barrett for future assets and a couple of smaller contracts. This could help them find a club willing to part ways with a future first to add Barrett's scoring.**Brooklyn Nets**: Above all else, the Nets will maximize opportunities to collect more assets and ensure they're at or near the top of next year's draft lottery. They should deal veteran forward Cameron Johnson, who has market value, to contending clubs while signing restricted free agent Cam Thomas to a reasonable deal.**Charlotte Hornets**: Under new management, the Hornets have adopted a slow, steady approach to their rebuild, and that seems unlikely to change this summer. Their main offseason work will be figuring out how to coax better health outcomes from LaMelo Ball and Brandon Miller.One move they should make is announcing Moussa Diabate as the starting center. The former Clipper signed a two-way contract with the Hornets last year and was quietly impressive in 71 games (eight starts) with Charlotte.The Hornets brought in two players from France and the United States, Diabate and Ball, who both played with Miller. In small sample games, their team had a plus-5.4 net rating, which is very good news for them. Because Williams isn't on the team anymore, Diabate should get to play more as he has an uncertain contract next year.
